

Confirmation of identity for voice cloning

Background

You (the Client) wish to generate a clone of your voice using ElevenLabs' technology.

We (ElevenLabs) are committed to online safety and the ethical use of our voice cloning technology. For this reason, we check that you generate digital reproductions, or clones, of your own voice with your consent. We do so by verifying your identity and comparing various voice samples you provide following our instructions.

This process is not always suitable if you wish to generate a clone of your former voice which is different from your current voice due to personal circumstances like a medical condition, disability or gender reassignment.

When this is the case, we ask that you provide evidence of such personal circumstances which may include information related to your health. Specifically, we ask that you provide information like your name, a copy of your identity document, a description of your personal circumstances and evidence confirming your personal circumstance.

We understand this information may be sensitive, therefore we want to highlight that:

- We will maintain this information safe and confidential according to applicable laws.
- We only collect information which is necessary for us to verify your identity and only for this purpose.
- We will only use the information you share in this form with your consent.
- You have the right to withdraw consent from us collecting and processing this information. Contact our support team if you wish to do so.
- You also have the right to request us to erase this information by contacting us with your request.
- The information you shared with us will be erased if you delete your account.
