

Investigating the clinical decision-making process and implementation of Makaton by speech-language therapists in New Zealand

Kia ora, my name is Chloe Hamilton-Walter, I am completing my fourth year of the Speech and Language Therapy programme at Massey University. I would like to invite you to participate in my Honours research project focused on exploring the clinical-decision making process and implementation of Makaton by speech-language therapists (SLTs) in New Zealand.

I aim to investigate the decision-making process of SLTs in New Zealand by determining the factors that influence their decision to choose Makaton as an intervention method. The implementation approaches and perspectives on barriers and facilitators will also be explored. This survey will contribute to current literature concerning how and why SLTs use Makaton, as well as exploring the strengths and challenges of using Makaton in the New Zealand context.

Project Procedure

The survey will be an online questionnaire.

Participants will be asked to disclose and describe any affiliations with The Makaton Charity.

Data Management

There are no identified risks to being part of the project. The results will be presented in my Honours research report and may be published in journal articles or presented at conferences.

The report will not contain any real names or identifying information. The only people who will have access to the information will be myself and my supervisor. Information will be stored on password protected computers or in a locked filing cabinet in Dr. Clendon's office. Information will be kept for 5 years after the completion of the final publication. When disposed of, the University confidential waste service will be used.
